COVID-19 RENTAL ASSISTANCE

PROVIDING STABILITY

Susan, a divorced mother of 2, was barely making ends meet when the pandemic hit and she lost both of her jobs. Having lived pay check to pay check "just to survive," Susan was fearing homelessness as she was unsure how she was going to pay her rent. But CPAH was her "lifesaver," and provided rental and utility assistance so Susan was able to stay in her beloved apartment. Susan is not only relieved, but relishing the stability that comes with having a safe place to call home.



I was able to breathe because of CPAH. It's like someone gave me hope again, and I am so grateful. Without CPAH, I'm not sure what I would have done.



RE-ENTRY PROGRAM

Mark was approaching the end of his 4-year sentence when his prison counselor offered him the opportunity to obtain housing and rental assistance after release so that he "doesn't wind up coming back here." He jumped at the chance, and now Mark lives in a decent, safe one bedroom just down the road from his new job. The innovative new pilot program, a partnership between CPAH, the Illinois Department of Corrections (IDOC) and the Illinois Housing Development Authority, helps returning citizens reintegrate into the community and avoid recidivism. Mark is proud that he is able to lead a productive life that started with securing a stable place to live.

BUILDING WEALTH THROUGH HOMEOWNERSHIP

This family of 3 was living in a rental apartment but longed for more space, and a more permanent home as their daughter entered her school-aged years. They saved, built their credit, and yet it was not enough to be able to afford a home in their community. CPAH's Community Land Trust program gave them the chance they needed to purchase an affordable home, and put down permanent roots in their community. They feel settled, optimistic, and happy to be building wealth through homeownership.

DOWN PAYMENT ASSISTANCE

Many families yearn to own a safe, permanent home but do not have the required down payment. CPAH's Down Payment Assistance Program (DAP) removes that barrier and has distributed **\$151,200** in down payment assistance to **20 households** this year alone.

Inclusionary housing (IH) programs are a critical part of the solution to the affordable housing shortage faced by so many communities. When affordable units are included in new residential developments, it has a big impact on those needing an affordable place to call home.

HOME ACCESSIBILITY PROGRAM

John was a successful sales manager when he was diagnosed with Myotonic Dystrophy, a rare auto-immune disease characterized by increasing muscle weakness. Now dependent on a wheelchair and living alone, this single father of 2 needed the doorways widened throughout the house, including the bathrooms, and to have ramps installed. CPAH's Home Accessibility Program (HAP) provided those improvements, and John is grateful for his independence.
